5. Proposal to discontinue offering the EdD in Educational Policy and Leadership Studies (Higher Education) subprogram and (PK-12 Administration) subprogram at Briar Cliff (Sioux City), Learning Center.

A vote to approve the proposal was undertaken. Beck made a motion to approve the proposed change. The motion was seconded by O'Shaughnessy. The motion passed unanimously.

6. Proposal to close Second Language Acquisition (PhD and PI) in the Division of World Languages, Literatures, and Cultures.

7. Proposal to extend interim or temporary acceptance of Duolingo English Test through Fall 2026 admission cycle and raise the minimum required score from 105 to 120. Dean Thein provided a summary of this proposal and background. After discussion a vote to approve the proposal was undertaken. Buck made a motion to approve the proposed change. The motion was seconded by Hribar. The motion passed unanimously.
